- Reproductions of original work, identified as such, are permitted.
- Grids are 6' vertical and 20' horizontal. All artwork, equipment personal belongings, etc., MUST be kept in the allotted space area
- SALES TAX- All exhibitors will be furnished a "ONE TIME TAX PERMIT" by the Nevada Dept of Taxation
- No PETS are allowed in the Gymnasium – No radios or any amplified system allowed (Personal systems with headphones are allowed)
- SECURITY – Facility will be locked each night, however, each exhibitor is responsible for their own artwork and personal property. Neither the BOULDER CITY ART GUILD nor The CITY OF BOULDER CITY is responsible for any loss from any cause whatsoever
